Migration analysis plastics

Samples of the product, or a similar product made from identical plastic material, have been tested for overall migration according to the test conditions specified in (EU) 10/2011, and the article comply with the overall migration limit of 10 mg/dm<sup>2</sup> or 60 mg/kg.

Test conditions for overall and specific migration were OM2 (10 days at 40 °C)

Food simulants used for overall migration were 10 % ethanol (simulant A), 3 % acetic acid

(simulant B) and olive oil (simulant D2).

Compliance with specific migration limits, and other restrictions, has been documented

through testing, calculation or simulation.
